### Battle over; Gun Lake Tribe wins the casino war

The Dorr Business Association is pleased that the Gun Lake Tribe can at last lay claim to the 147 acres it has set aside for the future site of its Gun Lake Casino.

The federal government placed the land into trust ending a long and arduous battle with MichGo and 23 is Enough.

“Today we rejoice knowing that all our hard work has paid off and the sacrifices of our ancestors was not made in vain,” said D.K. Sprague, Tribal Chairman. “Now it’s official. Justice has been served to those who were motivated by greed and power to delay this project for nearly ten years.”

### Dorr Industries operates under auspices of TG Manufacturing

TG Manufacturing purchased Dorr Industries in December. President Rich Achtenberg explained TG Manufacturing is a division of the Tora Group, a diverse, Michigan-based group of manufacturing and service companies. Tora Group companies include TG Renewable Energy Systems, a global system supplier to the renewable energy industry and TG Global Tooling Alliance.

Achtenberg anticipates expanding Dorr Industries’ customer base and processing. Teams from both companies have planned strategic integration of both company’s products and employees. Achtenberg said the 15 employees of Dorr Industries will continue to serve in their present ca-

The casino land title was transferred to the United States government to be held in trust on behalf of the Tribe. The Department of the Interior authorized the title transfer, which is not open to a legal challenge. This action ends any legal ambiguity about the Tribe’s ability to conduct gaming in accordance with federal law.

Soon the Tribe will hold a press conference to announce a ground breaking date, provide information for those who want to apply for a casino job, and inform area business owners how they can bid on contracts for goods and services.

The Gun Lake Casino will be op-

erated by the Tribe’s management partner, Station Casinos.

On Wednesday, Feb. 11, the Michigan State Senate followed suit and passed a resolution approving the compact with the Tribe.

### Sewer project brings mixed emotions

Work is progressing on the planned sewer improvements in Dorr Township. The \$1.54 million project has received a couple of monetary pledges from Wayland Union School, \$137,000 and the Downtown Development Authority for \$400,000. The remainder is being sought through public assessments and grant monies.

Supervisor Tammi VanHaitsma said she is exhausting all resources for assistance, looking at stimulus packages and other grant monies available.

“At this time a draft assessment role is available and two petitions have left our office, one for and one against the project,” said VanHaitsma. “We’re waiting to see what we get back and then we’ll determine if we want to set up a public hearing on this.”

The township is looking at extending the sewer line from downtown Dorr west to the park and south along Hickory to Dorr Elementary School.

VanHaitsma said the sewer is much needed and with the coming of the casino will be a valuable asset to development that will sure to follow.
